Oral Item: Update on Afghanistan

Portfolios Foreign Affairs / Defence

On 25 August 2021, the Cabinet Business Committee:

- 1 **noted** that on 16 August 2021, Cabinet:
 - 1.1 agreed in principle that Afghan nationals may be considered for resettlement in New Zealand, if they met certain specified criteria (the resettlement criteria);
 - 1.2 authorised a group of Ministers (the Prime Minister, Minister of Finance, Minister of Foreign Affairs, Minister of Immigration and Minister of Defence) to have Power to Act to take further decisions on New Zealand's response to the situation in Afghanistan and the deployment of New Zealand Defence Force assets and personnel to assist with international efforts to extract nationals and approved Afghan citizens, and the criteria for resettlement;

- 2 **noted** that the number of individuals who have been approved by officials for resettlement in New Zealand, including those individuals' immediate nuclear families, is significantly higher than anticipated;
- 3 **directed** officials to rigorously apply and retest the application of the previously approved resettlement criteria, and to investigate the options available in relation to any visas that are currently being processed for those individuals who may not meet the previously approved resettlement criteria;
- 4 **noted** that the evacuation window is closing imminently, and that it is likely evacuation flights from Hamid Karzai International Airport will no longer be possible from 26 August 2021;
- 5 **agreed** that New Zealand should stop accepting applications under the resettlement criteria referred to in paragraph 1 above as at 23.59 hours on Wednesday, 25 August 2021;

6 **directed** officials to provide further advice to Ministers on options to manage the current and any future requests for New Zealand assistance from individuals in Afghanistan, including multilateral processes such as the United Nations High Commissioner for Refugees.
