## PROPOSED OVERSEAS TRAVEL: NEW YORK, USA, 30 JULY - 6 AUGUST 2022

- I seek Cabinet approval to travel to New York, USA, from 30 July to 6 August 2022. The purpose of travel is to represent New Zealand at the Nuclear Non-Proliferation Treaty (NPT) Review Conference (Rev Con).
- 2 The Prime Minister has approved the travel in-principle and House leave has been sought from the Party Whip.
- 3 The Minister of Foreign Affairs Hon Nanaia Mahuta has agreed to the recommendation by the Ministry of Foreign Affairs and Trade that I lead the New Zealand delegation to the meeting.

#### **Purpose of Travel**

#### NUCLEAR NON-PROLIFERATION TREATY REVIEW CONFERENCE

- The purpose of travel is to attend the Nuclear Non-Proliferation Treaty (NPT) Review Conference (Rev Con) in New York. The NPT is the cornerstone of the international nuclear disarmament and non-proliferation architecture, with this Review Conference viewed as pivotal for the ongoing credibility of the Treaty. It will be the first such meeting of treaty parties since the failure to reach agreement on a substantive outcome in 2015. There is widespread recognition that the nuclear disarmament and non-proliferation norms at the heart of the Treaty are under increasing stress.
- Ministerial attendance at the Review Conference would send a clear signal of New Zealand's support for the NPT and help give New Zealand the best chance to influence a positive outcome from the meeting. It would also provide an opportunity to re-connect with Ministers from across the NPT membership and to demonstrate that our active engagement on the Treaty on the Prohibition of Nuclear Weapons is in addition to, not instead of, our ongoing commitment to the NPT.

- All our likeminded partners in disarmament will be represented at the Review Conference. It is the international community's pre-eminent opportunity to engage with the Nuclear Weapons States and attempt to hold them to the disarmament and non-proliferation bargain that underpins the Treaty. We have also been an active participant in the ministerial-level Stockholm Initiative co-chaired by Sweden and Germany which is an attempt to ensure a positive outcome in New York, and the New Agenda Coalition. Ministerial participation in the Review Conference is consistent with our disarmament and arms control work and reflects the significance of the Conference as an important moment for influence.
- The visit will also provide an opportunity for me to connect with senior United Nations personnel on a broad range of disarmament, non-proliferation and other multilateral issues, including to discuss the impact of the conflict in Ukraine on the peace and security agenda.
- 8 Whilst in New York, I will seek to:
  - Lead the New Zealand delegation at the NPT Review Conference High Level
     Segment, including the delivery of New Zealand's national statement
  - Hold bilateral meetings with other Ministers in the margins of the Review Conference
  - Hold meetings with leading disarmament coalition partners (New Agenda Coalition, Treaty on the Prohibition of Nuclear Weapons core group, Stockholm Initiative members)
  - Meet with nuclear disarmament NGOs and civil society representatives
  - Call on UN leadership: Under Secretary-General of Disarmament Affairs Izumi Nakamitsu
  - Participate in a call or event relating to the Peacebuilding Commission, of which New Zealand is currently a member
  - Participate in other calls relating to Russia's invasion of Ukraine
  - Host a meeting with Pacific representatives.
- 9 Logistical challenges related to COVID-19 may impact the planning of the conference. Should this be the case, alternative means for New Zealand's participation will be explored.

#### **Travel**

10 If travel is approved, I propose to depart New Zealand for New York on Saturday 30 July and will return to New Zealand on Saturday 6 August 2022. I would return to Parliament on Tuesday 9 August 2022.

## **Ministerial Party**

11 I would be accompanied by one staff member from my office (and one official from the Ministry of Foreign Affairs and Trade).

#### **Costs of Travel**

12 The projected costs of the proposed travel for the Ministerial Party are:

- 13 Contingency costs are based on 20% of the overall cost of this trip, due to the uncertainty caused by COVID-19.
- 14 Expenditure of up to \$53,400 for travel expenses is proposed to be a charge to Vote Internal Affairs: Members of the Executive Travel.
