- How much has the Ministry of Foreign Affairs and Trade spent on consultants/external agencies in 2022?
- Which consultants/agencies were paid the most amount by the Ministry of Foreign Affairs and Trade in 2022? How much was that? What did they do?
- How many staff were employed in the area of graphic design? How much is the total salary cost? How much was spent on external design consultants/agencies in 2022?
- How much has been spent on polling, focus groups, market research in 2022? What was the focus of this research?

We have answered your questions in turn below. Please note financial figures are exclusive of GST.

## How much has the Ministry of Foreign Affairs and Trade spent on consultants/external agencies in 2022?

Information regarding expenditure related to consultants and external agencies is publicly available on page 84 of the 2021/22 Annual Report of The Ministry of Foreign Affairs and Trade (the Ministry). ## Which consultants/agencies were paid the most amount by the Ministry of Foreign Affairs and Trade in 2022? How much was that? What did they do?

Pae (New Zealand Ltd) was paid NZD\$269,067 for a Pacific Regional Property Condition Survey and Plan. This work involved undertaking detailed inspections and condition surveys, data capture and maintenance plans of all 55 properties in the Pacific region

How many staff were employed in the area of graphic design? How much is the total salary cost? How much was spent on external design consultants/agencies in 2022?

During the 2021/2022 year the Ministry established two permanent roles in the area of graphic design. The two roles are employed in the following salary bands:

NZD\$54,250 was spent on external design contractors during the 2021/22 year to backfill vacancies. NZD\$28,182 was spent by Embassies to contract visual design services.

## How much has been spent on polling, focus groups, market research in 2022? What was the focus of this research?

Information regarding expenditure relating to consultants and external agencies is contained within the Ministry's Annual Review, carried out by the Foreign Affairs, Defence and Trade Select Committee.
