- 3- Any other information held about the guest list, agenda for this WEF meeting deciding who will attend and the purposes for them attending
- 4- The NZ government budget for attendances at the Jan 2023 Davos meeting
- 5- Copies of any financial or other contributions directly or indirectly from the WEF and/ or Klaus Schwab to NZ government or any Minister or other Member of Parliament
- 6- Please include any analysis or other information assessing any benefit or risks for NZ from its relationship with the WEF, for this meeting or generally and any interference this relationship may have on democracy in New Zealand or the perception of democracy in NZ."

On 26 January 2023, you were advised that your request was transferred to the Ministry of Foreign Affairs and Trade (the Ministry) for response.

Regarding Item 4, this is covered in the document "Proposed Overseas Travel: Hon Damien O'Connor, 17-25 January 2023, Switzerland, Germany, UK" that is set to be published on the Ministry's website soon and will be accessible via the link below. This document is therefore refused under section 18(d) of the OIA, as the information will soon be publically available.

#### Pito matua – Key points

- The 2023 World Economic Forum (WEF) Annual Meeting will be held, as usual, in Davos, Switzerland on 16-20 January. WEF's Annual Meeting is a major event that welcomes public and private leaders for dialogue on the world's most pressing issues and attracts significant international media coverage. Attendance would provide an excellent opportunity to lift New Zealand's international profile and highlight the country's international leadership on a range of priority policy issues.
- The World Economic Forum has invited the Prime Minister, the Minister of Finance, the Minister of Foreign Affairs and the Minister for Trade and Export Growth. The World Economic Forum has been active in reaching out to the Prime Minister including in drafting up a proposed itinerary of events. However, we recommend that the invitation be taken up only by the Minister for Trade and Export Growth, given the number of priority trade meetings scheduled in the margins of the meeting.
- These meetings include an informal WTO mini-Ministerial meeting hosted by Switzerland on 20 January, the potential launch of the Trade Ministers for Climate Coalition, an Ottawa Group meeting (likely 19 January), and a possible WTO E-commerce Joint Statement Initiative Ministerial, along with opportunities for bilateral meetings with CPTPP and Pacific Alliance members and other partners.
- This travel would sequence well following the Global Forum on Food & Agriculture (GFFA) Ministerial which is scheduled for 18 January in Berlin, Germany. From there, the Minister could then travel to Davos for the final two days of the meeting 19-20 January (two days is the usual duration of Ministerial attendance at Davos).

#### Pūrongo – Report

#### World Economic Forum

- 1. The theme of the 2023 World Economic Forum Annual Meeting is "Cooperation in a Fragmented World". In previous years, New Zealand has been represented by the Minister for Trade and Export Growth (in January 2020), by the Prime Minister (in 2019) and by the Minister of Finance (in 2019 and 2018). Due to the wide range of issues canvassed at Davos, attendance by a range of leaders can be accommodated within the diverse mix of panels and events, targeting foreign affairs, trade, environment and financial issues among others. WEF have advised that they are expecting around 50 Trade Ministers in attendance at the 2023 Annual Meeting.
- 2. As seen in previous years, and reinforced in recent engagement with WEF, the WEF executive greatly values New Zealand's attendance (particularly at leader level) and will actively engage in crafting specific opportunities to support Ministerial or Prime Ministerial interests. For instance, WEF have suggested for an MTEG programme a Trade and Indigenous Peoples event that would showcase New Zealand's Trade for All Approach. Equally if the Prime Minister was to attend, then the WEF has offered to create a bespoke itinerary including a "New Zealand night" and a series of opportunities to promote New Zealand and New Zealand initiatives (see proposed agenda). This, however, may also reflect a desire by the organisers to encourage more leader level attendance at the summit.
- 3. If you choose to attend, officials will work with WEF to prepare a suitable programme and investigate leveraging associated international media opportunities, as well as engage with Treaty Partners should the proposed Indigenous event be progressed. The World Economic Forum does not extend invitations to officials, so New Zealand will not be represented should you decline.

#### WTO mini-Ministerial

- 4. Switzerland has for many years now hosted an informal WTO mini-Ministerial meeting in the margins of the World Economic Forum (WEF) in Davos, inviting a group of around 30 key Trade Ministers along with the WTO Director General. The mini-Ministerial involves key players in the WTO and is an opportunity to review global trade developments and discuss prospects for negotiations in the coming year. Russia's invasion of Ukraine, including the risks to global food security which it has caused, will be a major backdrop to the 2023 meeting.
- 5. The January 2023 meeting will provide a timely opportunity to review the outcomes from the 12th WTO Ministerial (MC12) and for New Zealand to advocate for progress on priority issues ahead of the next Ministerial meeting (MC13 which will likely occur in early 2024). In particular, to discuss the prospects for the agriculture negotiations and to canvass the views of other Members on how best to progress ratification of the WTO Fish Subsidies Agreement, reform of environmentally harmful subsidies (fisheries, agriculture, fossil fuels) and to maintain momentum on WTO reform.

6. New Zealand has been a regular participant in the Swiss hosted meetings. Your participation is instrumental in reinforcing our credentials for continued inclusion in the small group meetings, which, as demonstrated at MC12, determine whether and how progress is made in the WTO. It also underlines New Zealand's commitment to safeguarding the credibility and effectiveness of the WTO system.

#### Other Opportunities

- 7. In addition to the WTO mini-Ministerial, we are anticipating that a range of other WTO related events and meetings will be held in Davos. These include the launch of the Trade Ministers for Climate Coalition (see below), an Ottawa Group meeting (indicative timing of 19 January), and potentially a WTO E-commerce joint statement initiative (JSI) ministerial.
- 8. While we have very limited information at this stage on the Ottawa Group meeting and the JSI ministerial, your attendance at these two events would underscore the significance New Zealand places in progressing WTO reform and on continuing progress in the e-commerce negotiations. The Ottawa Group in particular will be a critical opportunity to align (as far as possible) approaches on reforming the dispute settlement system and to reiterate New Zealand's ambitions for restoring a fully functioning and binding dispute settlement system. The timing of the meeting, coming at the planned conclusion of the informal US-convened process on dispute settlement reform, could be an important waypoint.
- 9. As agreed with 'Co-Chairing' Ministers from the EU, Kenya, and Ecuador in July 2022, Davos is the preferred place to launch the Trade Ministers for Climate Coalition (the Coalition). The range of stakeholders at Davos, including Trade Ministers invited to the WTO mini-Ministerial as well as others, business leaders, NGOs and international organisations, will enable a successful event to launch and promote the Coalition and encourage a strong uptake in membership.
- 10. Officials from the 'Co-Chairs' are progressing a number of key work pieces for the Coalition in preparation for an early-2023 launch. If the Coalition is not launched at Davos, then the next possible event for launch would not be until COP28 or MC13 in early 2024.
- 11. This trip also offers the opportunity for a potential stop in Türkiye to hold the 10th New Zealand Türkiye Joint Economic Commission (JEC). 59(2)(9)(1), 56(a)
- 12. Holding the JEC in the margins of your trip to the World Economic forum would capitalise on the narrow window for engagement with the relevant Turkish Minister before the upcoming Turkish elections, due to take place in June 2023. s9(2)(g)(i), s6(a)

# Cooperation in a Fragmented World



#### DAVOS-KLOSTERS, 16-20 JANUARY

The world today is at a critical inflection point. The twin triggers of the COVID-19 pandemic and the war in Ukraine rattled an already brittle global system. Economic growth in the world's largest economies is stalling, while navigating headwinds from rising food and energy prices. For the first time since the 1970s, the world is facing a precarious disequilibrium with growth and inflation moving in oppositive directions. This is occurring alongside heightened geo-economic fragmentation, financial sector vulnerabilities, including stretched asset prices and high debt levels, and a climate crisis spiralling out of control, which could magnify any growth slowdown, particularly in emerging markets. Unless these systemic and interconnected risks are addressed, the promise of a "decade of action" may become a decade of uncertainty and fragility.

Against this unprecedented backdrop, the World Economic Forum is convening its 53rd Annual Meeting in January to reaffirm the value and imperative of dialogue and public-private cooperation, not only to navigate the current cascading crises but, more importantly, to drive tangible, system-positive change for the long term. For over 50 years, the World Economic Forum has provided space for leaders to engage in peer-to-peer deliberations in the spirit of improving the state of the world. Never has this mission been more important. Therefore, finding ways to reinstitute a collective sense of agency and to turn defensive measures into proactive, vision-driven policies and business strategies will be at the heart of the meeting. The magnitude of current crises and the potential of future ones demands no less.

#### The Programme

The basic tenet of the programme is the premise that the current crises, as serious as they are, are manifestations of larger systemic deficiencies accrued over time. They are also the result of a narrow vision of systems as sectors rather than true multidisciplinary, networked entities that are highly dynamic, particularly in the context of the meta trends of the Fourth Industrial Revolution and climate change.

Therefore, thematically, the programme will have the dual focus of looking at levers to address the current challenges while at the same time setting them against the backdrop of attendant system transformation imperatives.

Concretely, we will look at:

# Addressing the Current Energy and Food Crises in the context of a New System for Energy, Climate and Nature

Energy transition and climate change are inextricably linked, with its impact being felt in recent months. While a global energy transition is under way, further action is needed to reduce carbon emissions and mitigate the effects of climate change. Critical measures to accelerate energy transition include decoupling economic growth from energy consumption, particularly in emerging economies, mainstreaming breakthrough technological innovations and addressing equity. Rather than using the ongoing crisis as a pretext to forego policies that support the transition to more sustainable energy sources, this moment should be utilized to develop more ambitious, comprehensive, and sustainable infrastructure investment plans that helps the world to meet the 2030 targets.

#### Addressing the Current High Inflation, Low Growth, High Debt Economy in the context of a New System for Investment, Trade and Infrastructure

Policymakers are now operating with limited fiscal space, while inflationary pressure is forcing a tightening of monetary policy. Tighter monetary policies are also having knock on effects on emerging markets, with many now struggling to service their debts. Protectionist measures also threaten the global trade agenda which was at the centre of economic prosperity of the last 30 years. This comes following the COVID-19 pandemic which has pushed 120 million additional people into extreme poverty and exposed the underfunding of critical infrastructure across markets. In a multipolar world, refashioning the economic agenda along strategic lines and rebuilding trust in the international system will take careful collaboration between all stakeholders and a new vision for economic prosperity and development.

#### Addressing the Current Industry Headwinds in the context of a New System for Harnessing Frontier Technologies for Private Sector Innovation and Resilience

Industries are being forced to reassess their investment, production and innovation decisions with the advent of the Fourth Industrial Revolution (4IR), climate change and geopolitical fragmentation of recent years. To navigate the current friction points and to strengthen future competitiveness, companies will need to foster emerging technologies of 4IR as well as optimize for agility. They will also need to realize stakeholder capitalism through core business and operating models not only to drive resiliency today but also to shape the future socio-enviroeconomic prosperity. To do so successfully, collaboration must be strengthened across increasingly diverse ecosystems, including competitors, companies in other industries and innovators.

#### Addressing the Current Social Vulnerabilities in the context of a New System for Work, Skills and Care

Official statistics show that despite a growing global economic crisis, workers are continuing to leave - or considering leaving - their jobs. Notwithstanding high numbers of unfilled jobs and tight labour markets across many of the world's biggest economies, real wages are also declining across many job categories in the midst of a cost-of-living crisis. In parallel, emerging markets are facing pressure of significant unemployment driven by the economic slowdown, leading to heightened social pressure. This moment calls for a new social contract that supports strong investment in education, skills and healthcare that fills unmet demand, lays the ground for social mobility and ultimately futureproofs economies.

# Addressing the Current Geopolitical Risks in the context of a New System for Dialogue and Cooperation in a Multipolar World

Systems that brought common benefit, such as trade, have been used as weapons to punish rivals, and areas that were once paragons of cooperation, like climate change, are at risk of becoming frontlines of competition. Russia's invasion of Ukraine was the latest move away from what was, for the first quartercentury after the end of the Cold War, a largely cooperative global order. The geopolitical vane turned from cooperation to competition. There is a growing need for a new global system that is more stakeholder based and equipped to handle the dynamics of the 21st century.

A special workstream across these themes will be dedicated to **leadership**, with a particular focus on resilience both at the individual and organizational levels.

The meeting will also enable the Forum's **Global Collaboration Village**, a pioneering effort to further scale public-private cooperation on the world's foremost challenges utilizing immersive digital environments.

### The Meeting

The meeting will take place from 16 January to 20 January. The four days will cover a wide spectrum of formats for interaction and learning, giving leaders the necessary tools to address the current complexity and build for the future. They will revolve around the following three archetypes:

- Dialogues to forge understanding and alignment and exchange insights
- Gatherings of communities of purpose to drive tangible action on key global issues
- Opportunities for foresight and discovery to scale society critical innovations

The meeting will feature addresses by key heads of state and government as well as various geo-economic and geopolitical deliberations such as the Country Strategy Dialogues, Diplomacy Dialogues and the Informal Gathering of World Economic Leaders (IGWEL) meetings. It will also gather the Forum's foremost business communities, such as the International Business Council, the Community of Chairpersons and the Industry Governors.

Many sessions will be livestreamed publicly on the Forum's website and social media channels, as well as its state-of-the-art digital app, TopLink, providing an opportunity for the Forum's Digital Members community and the public to engage in deliberations. In addition, timely expert briefings will help participants and the public gain insights on the latest developments in current affairs at the time of the meeting.
