#### Report on Overseas Travel: Hon Damien O'Connor

1 I recommend that Cabinet note this report on my travel to Singapore from 7-10 October 2022.

## Report

- The focus of my visit was the 6th Commission Meeting for the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPR).
- The Commission meeting was the centrepiece of Singapore's hosting year and the first opportunity for CPTPP ministers to meet in person since the start of the COVID-19 pandemic. The discussion focused on accession matters, CPTPP implementation (including Singapore's green economy and digital economy initiatives) and the global and regional economic context. These issues were canvassed in a publicly-released Joint Ministerial Statement and Chair's Report.
- 4 Ministers reviewed the progress made over the last year on the implementation of CPTPP against the backdrop of the COVID-19 economic recovery. There was consistent acknowledgement that CPTPP is an important part of the region's economic trade architecture, and on the importance of maintaining its high standards going forward. (56(a), 56(b)(i)
- My own interventions during the meeting highlighted the inclusive trade benefits of CPTPP, and provided an update on New Zealand's work to consider the effectiveness of CPTPP in fostering progressive and inclusive trade through a review, conducted under the auspices of the Inclusive Trade Action Group (ITAG). ITAG (New Zealand, Canada, Chile and Mexico) is committed to reviewing the effectiveness of CPTPP in relation to sustainable development, gender, indigenous peoples, domestic regional economic development, small and medium enterprises, labour rights, the environment and climate change, within three years of entry into force. New Zealand is in the process of finalising its review and I reported to the Commission on its preliminary findings most notably, that inclusive themes need to be better integrated in to CPTPP committee-level work programmes.

I also held formal bilateral meetings with Japan's then-Minister in Charge of Economic Revitalisation Daishiro Yamagiwa, Canadian Minister of International Trade Mary Ng, and Australian Assistant Minister for Trade Tim Ayres.

had the opportunity to connect informally with a range of counterparts from CPTPP Parties, including a good discussion with Chilean Vice-Minister José Miguel Ahumada on s6(a), s6(b)(i)

- The meeting was a timely opportunity to begin to socialise New Zealand's priorities for our year as CPTPP Chair and Commission host in 2023. These will include the following objectives:
  - i. Advancing ratifications and accessions;
  - ii. Effective and improved implementation of CPTPP;
  - iii. Promoting inclusive and sustainable trade; and
  - iv. Developing a high-quality and authentic host year.
- The value of bringing together the CPTPP Ministers in-person for the Commission meeting was borne out in the political direction provided on the UK's accession, the opportunity to share views on the wider accession process, and the reaffirming of the value of CPTPP to members (particularly the inclusive element of the Agreement). \*\*S6(a), \*S6(b)(i)\*\*

In addition to the CPTPP-related aspects of the visit, I took part in a closed roundtable event with the New Zealand Chamber of Commerce in Singapore and visited a vertical farm. These events provided an opportunity to engage with New Zealand businesses and key opinion leaders on the regional outlook for business, showcase the Trade Recovery Strategy, and gain an understanding of how industry can contribute to Singapore's food security goals.
