Proposed Overseas Travel: Hon Nanaia Mahuta

On 13 March 2023, Cabinet:

- authorised the absence of Hon Nanaia Mahuta from New Zealand, subject to leave from Parliament being secured, from 15 to 17 March 2023, to travel to Fiji to undertake a bilateral visit;
- agreed that she be accompanied by one member of staff;
- **approved** the expenditure of up to \$13,292 for the travel expenses of the ministerial party as a charge to Vote: Internal Affairs (Members of the Executive Travel);
- 4 **noted** that she will also be accompanied by officials from the Ministry of Foreign Affairs and Trade whose costs will be met by their agency;
- **agreed** that in her absence Hon David Parker act as Minister of Foreign Affairs and Minister for Disarmament and Arms Control;
- 6 **noted** that leave from Parliament has been sought.

Proposed Overseas Travel: Hon Nanaia Mahuta

- 1 I seek Cabinet approval to travel to Fiji from 15 March 17 March 2023 to undertake a bilateral visit.
- 2 The Prime Minister has approved the travel in-principle, and House leave has been sought from the Party Whip.

Reasons for Travel

- 3 This visit will be Aotearoa New Zealand's first bilateral ministerial travel to Fiji since its General Election in late 2022, and my first kanohi ki te kanohi engagement with key figures from Fiji's new coalition government.

New Zealand has long-established, deep links with Fiji through government-to-government relations, regional security, trade, and deep community links through the Fijian communities who have made New Zealand their home. In addition, Fiji is home to the region's key institutions, including the Pacific Islands Forum (PIF) Secretariat. s6(a)

- It is against this background that I consider it is timely for me to develop my relationship with Fiji's new Prime Minister and Minister of Foreign Affairs Sitiveni Rabuka, to build relationship ballast and trust with other members of the new government, grow the bilateral relationship, express New Zealand's priorities and aspirations for Fiji and the Pacific, and to discuss the issues facing our region.
- 9 I will use the opportunity to:
 - Build a relationship with the new Fiji Government leadership who were elected in late December 2022, s6(a)
 - Reinforce Aotearoa New Zealand's position as a natural partner for Fifi and the broader region, and demonstrate solidarity on important issues such as climate change and regional security.

Travel

14 If travel is approved, I will depart New Zealand for Fiji by commercial means on Wednesday 15 March and will return to New Zealand on Friday 17 March 2023.

Ministerial Party

Should Cabinet approve my travel, one of my private secretaries will accompany me paid for by ministerial services, along with officials from the Ministry of Foreign Affairs and Trade, whose costs will be met by the budget of the Ministry of Foreign Affairs and Trade.
