Proposed Overseas Travel: Hon Rino Tirikatene

Portfolio Trade and Export Growth

On 14 August 2023, Cabinet:



- authorised the absence of Hon Rino Tirikatene from New Zealand, subject to leave from Parliament being secured, from 20 to 26 August 2023, to travel to Semarang and Jakarta, Indonesia to attend the signing of the Upgrade of the Agreement to establish the ASEAN-Australia New Zealand Free Trade Area and for bilateral discussions;
- 2 **agreed** that he be accompanied by one staff member;
- 3 **approved** the expenditure of up to \$43,618.56 for the travel expenses of the ministerial party as a charge to Vote Internal Affairs (Members of the Executive Travel);
- 4 **noted** that he will also be accompanied by officials from the Ministry of Foreign Affairs and Trade whose costs will be met by their department;
- 5 **agreed** that in his absence Hon Ginny Andersen act as Minister for Courts;
- 6 **noted** that leave from Parliament has been sought.

Overseas Travel: Hon Rino Tirikatene

- 1. I seek Cabinet's approval to travel to Semarang and Jakarta, Indonesia from 20 26 Font August.
- 2. The Prime Minister previously approved in-principle my travel to:
 - a. Semarang, Indonesia (20-23 August), and
 - b. Suva, Fiji (23-28 August).
- 3. My travel to Semarang includes ASEAN Ministerial meetings, and the signing of the Upgrade of the Agreement to establish the ASEAN-Australia New Zealand Free Trade Area (AANZFTA).
- 4. My planned travel to Fiji included attending the Pacific Island Forum Trade Ministers' Meeting (FTMM). However, due to a s6(a) opostponement of the FTMM meetings, I am seeking Cabinet's approval to:
 - a. drop Fiji from the travel programme, and
 - b. amend the Indonesia programme to include an additional stop in Jakarta. This would allow me to conduct bilateral business and would make the most of having a Minister in the ASEAN region.
- 5. The proposed new itinerary allows me to maximise the bilateral relationship benefits of my visit to Indonesia and reduces my overall time out of New Zealand by two days compared to the original itinerary.

Reasons for Travel

- 6. The purpose of my travel to Indonesia is to advance New Zealand's trade and export growth interests in my capacity as Minister of State for Trade and Export Growth.
- 7. New Zealand's interests include the Upgrade of AANZFTA, and attending the annual suite of ASEAN-related ministerial meetings, involving members of ASEAN and their dialogue partners.
- 8. J-will also look to support the government's Trade Recovery Strategy and progress New Zealand's trade and economic interests in Indonesia's capital of Jakarta, where I will seek engagement with Ministerial counterparts and further New Zealand's business interests.

Semarang Programme

AANZFTA Upgrade

9. Significantly, the signing of the AANZFTA Upgrade will take place during this visit. This Upgrade will modernise the Agreement, further reduce barriers impacting imports, and boost trade in the Indo-Pacific region.

10. I will alongside my ministerial counterparts take part in the public ceremony, and signing of the Agreement. This will be important to signal the hard work that all Parties have committed to deliver on and will reaffirm the high value that New Zealand places in this Agreement.

ASEAN-Related Ministerial Meetings

- 11. The ASEAN-related ministerial meetings will include:
 - a. ASEAN Closer Economic Relations Partners (Australia and New Zealand) Consultation - New Zealand's primary Ministerial meeting with ASEAN on trade and economic matters;
 - b. East Asia Summit (EAS) Economic Ministers Meeting important for New Zealand's trade and export growth interests, due to the diverse and strategically important membership including the USA, Japan, China and Russia; and
 - c. **Regional Comprehensive Economic Partnership (RCEP) Ministers Meeting** the second annual meeting that will continue momentum on governance and implementation issues important to New Zealand.
- 12. New Zealand's attendance at ministerial level at the ASEAN-related meetings will reinforce our commitment to our partnership with ASEAN, and to ASEAN-centrality in the Indo-Pacific region. Ministerial travel, and building relationships with leaders face to face, is essential to protect and promote New Zealand's interests in the region.
- 13. The visit will highlight the importance of our trade relationship with ASEAN. It will be an important opportunity to demonstrate our commitment to, and help influence, the ASEAN-led regional economic architecture.
- 14. It will also acknowledge and deepen our relationship with Indonesia as a unique and highly trusted partner, as 2023 is Indonesia's year as ASEAN Chair.

Jakarta Programme

- 15. A bilateral programme in Jakarta will help to support the government's Trade Recovery Strategy and advance New Zealand's trade and economic interests in our second fastest growing export destination amongst our top markets (export growth of 26% over the last year alone).
- 16. A programme is proposed to include the following:
 - a. Ministerial-counterpart calls with Indonesian ministers;
 - b. Engagement in events with market experts, New Zealand companies (business roundtable/informal networking) and informal briefings with NZ government agencies in-market teams; and
 - c. New Zealand export-relevant site visits.
