Proposed Overseas Travel: Hon Nanaia Mahuta

Portfolio Foreign Affairs

On 20 March 2023, Cabinet:

- authorised the absence of Hon Nanaia Mahuta from New Zealand, from 22 to 26 March 2023, to travel to Beijing, China for a bilateral visit;
- agreed that she be accompanied by one member of staff,
- approved the estimated expenditure of up to \$45,590 for the travel expenses of the ministerial party as a charge to Vote: Internal Affairs (Members of the Executive Travel);
- 4 **noted** that the accommodation costs of the ministerial party will be met by the Chinese government;
- **noted** that she will also be accompanied by officials from the Ministry of Foreign Affairs and Trade, whose costs will be met by their department;
- **agreed** that in her absence Hon David Parker act as Minister of Foreign Affairs and Minister for Disarmament and Arms Control;
- 7 **noted** that the House is not sitting during her absence.

I seek Cabinet approval to travel to China over Wednesday 22 March – Sunday 26 March inclusive. Prime Minister Chris Hipkins has approved the travel in-principle, and the dates have been confirmed by China.

Executive Summary

- 2 This visit would be my first bilateral visit to China as Minister of Foreign Affairs.

China remains our largest trading partner, s6(a)

- I consider it is important to have a high level, in person, political engagement in China as a priority. This will be the first high level New Zealand visit to China since 2019.

- Both sides have worked hard to confirm a visit for several months, with a visit in 2022 not proving possible for various reasons, including because of China's recently rescinded COVID-19 restrictions.
- 7 A visit to China would deliver on the following objectives:
 - Establish a constructive working relationship with new Chinese Foreign Minister Qin Gang, building on my previous bilateral engagements with his predecessor Wang Yi.

 - Acknowledge the significance of the bilateral relationship and signal New Zealand's ongoing commitment to a relationship consistent with our interests and values.

invasion of Ukraine) as well as register at a high level New Zealand's concerns including regarding Taiwan, Xinjiang, and Hong Kong.

- Be a tangible demonstration of New Zealand's reconnection and economic recovery strategies, and reassure the business community of New Zealand's constructive engagement with our largest trading partner.
- Engage with our staff, and families, at the Embassy after a challenging three years under China's difficult COVID-19 restrictions.

Outline of Proposed Visit

- The visit would revolve principally around a face-to-face meeting and dinner with Foreign Minister Qin Gang on Friday 24 March.
- This visit may also include meetings with other senior Chinese officials. For example, MFAT officials will seek a courtesy call on the former Chinese Foreign Minister and newly appointed member of the Chinese Communist Party's Politburo Standing Committee and Director of China's Foreign Affairs Commission, Wang Yi. Officials are also exploring events with New Zealand businesses and expatriate communities based in China, women leaders in China, as well as time with the New Zealand Embassy staff and families and resident Pacific Missions.

Travel

If my travel is approved, I will arrive in Beijing on Wednesday 22 March, departing Auckland via Singapore. I will depart China on Saturday 25 March, returning to Auckland via Hong Kong on Sunday 26 March. The substantive elements of my visit will take place on Thursday 23 and Friday 24 March.

Ministerial Party

I propose to be accompanied by one staff member paid for by ministerial services. Officials from the Ministry of Foreign Affairs and Trade will also accompany me, with costs met by their department.
