Tēnā koe

I refer to your email of 7 December 2023 in which you request the following under the Official Information Act 1982 (OIA):

A detailed breakdown of New Zealand's financial contributions to each United Nations (UN) agency for the calendar years January to December 2022, and January to December 2023. This should include but not be limited to regular assessed contributions and any voluntary contributions.

On 25 January 2024, the timeframes for responding to your request were extended by an additional 20 working days because responding to your request necessitated the review of a large quantity of information (section 15A(1)(b) of the OIA refers).

On 26 February 2024, you were advised that a decision had been made on your request. Thank you for your patience.

We have interpreted your request to be for funding provided by the Ministry of Foreign Affairs and Trade (the Ministry) to core agencies within the United Nations. Please find the information relevant to your request attached noting that no information is being withheld.

As part of New Zealand's membership of the United Nations (UN), the Ministry pays an assessed contribution – the mandatory dues that all 193 Member States are obliged pay to be a member of the UN. The Ministry reports annually on our financial contributions to the UN in our Annual Report, which is published on the Ministry's website here:

www.mfat.govt.nz/en/about-us/mfat-annual-reports/.

The amount each Member State must pay is calculated using a complex formula that considers a country's wealth, population, and debt burden. Assessed contributions fund the day to day running of the UN and peacekeeping operations. Assessed contributions cannot be arbitrarily withdrawn or reduced by a Member State.

The Ministry also reports on its international development cooperation (IDC) contributions to United Nations Agencies as assessed development and humanitarian funding in the Annual Report(s). Contributions to UN agencies include core, programme, and project funding, which helps agencies deliver global development and humanitarian outcomes. New Zealand works with other Member States to closely monitor agencies' performance and governance, and we report on the progress towards our multilateral development goals in our annual reports.

Please note that some engagement with UN agencies is led by other New Zealand agencies, and contributions will be reported in their annual financial reporting and therefore are not included in this response.
