I refer to your email of 16 January 2024 in which you request the following under the Official Information Act 1982 (OIA):

I request all advice given to ministers (between 1 December 2023 and 12 January 2024) about making the attached statement, and the decision to sign NZ to the accompanying statement from the White House: https://www.beehive.govt.nz/release/nz-support-strikes-against-houthis

On 14 February 2024, the timeframes for responding to your request were extended by an additional 55 working days because responding to your request necessitated the review of a large quantity of information, and due to the consultations necessary to make a decision on your request. (Section 15A(1) of the OIA refers).

The information relevant to your request is attached. We have withheld some information under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government;
- 6(b)(i): to protect the passing of information from another government on a confidential basis;
- 9(2)(a): to protect individuals' privacy;
- 9(2)(g)(i): to protect the free and frank expression of opinions by departments;
- 9(2)(g)(ii): to protect officers and employees from improper pressure or harassment;
- 9(2)(f)(iv): to protect the confidentiality of advice tendered by Ministers of the Crown and officials; and
- 9(2)(h): to maintain legal professional privilege.

Where the information has been withheld under section 9 of the OIA, we have identified no public interest in releasing the information that would override the reasons for withholding it.

In addition, the document titled "Informal Note – United States request for New Zealand support for action against the Houthi", dated 10 January 2024, includes one paragraph that is in scope of your request. This paragraph is excerpted below (section 16(e) refers). Some information is being withheld under sections 6(a) and 6(b)(i) of the OIA:

If Ministers decided not to pursue a deployment option, *6(a), *s6(b)(i)

It is possible there might be a further joint statement before taking military action, which New Zealand could choose to join. In the event of subsequent military action, Ministers could either issue their own media statement or make remarks to the press conveying New Zealand's support.

Background

- On 10 January, Houthi forces launched 18 drones and 3 missiles at commercial shipping vessels in the Red Sea. This serious incident follows over two-dozen previous attacks by Houthi forces, including another serious incident on 31 December when Houthi forces fired on US military assets responding to a request for assistance by the Singapore-flagged Maersk Hangzhou vessel, which was under threat of hijacking. In response, the US Navy sunk 3 Houthi vessels and killed 10 militants.
- New Zealand joined a US-led statement of 43 countries on 19 December and a further statement on 3 January condemning Houthi actions and calling on the group to immediately cease its attacks. This followed a United Nation Security Council statement on 1 December condemning the attacks.

Foreign and Defence Ministers' statement on US/UK-led strikes on Houthi-controlled sites in Yemen

Rt Hon Winston Peters Hon Judith Collins

[Foreign Affairs] [Defence]

Foreign Minister Winston Peters and Defence Minister Judith Collins today expressed support for US/UK-led strikes against Houthi-controlled sites in northern Yemen.

"Houthi attacks in the Red Sea threaten the lives of civilian crew members, as well as freedom of navigation and the free flow of international commerce," the Ministers said.

"As a trading nation, New Zealand takes these attacks seriously. Nearly 15 per cent of global trade flows through the Red Sea and Suez Canal. Supply chain disruption in the Red Sea risks higher costs for New Zealanders, puts at risk exporter deals, and delays getting goods to and from markets in the Middle East, North Africa and Europe."

"New Zealand and its partners have been clear: Attacks against commercial shipping in the Red Sea are illegal, unacceptable, and profoundly destabilising. We have made repeated calls to that effect, including in a joint statement with 43 other nations on 19 December 2023, and a further statement supported by 13 nations on 3 January," Mr Peters said.

"These warnings have not been heeded. The Houthi have only stepped up their attacks, as we saw on 10 January with the launch of 18 drones and three missiles at commercial shipping vessels in the Red Sea. Today's response is the inevitable consequence of their disregard for international law, peace and stability," Judith Collins said.

"The United Nations has also been clear on this issue. The UN Security Council adopted a resolution on 11 January demanding that the Houthis immediately cease their attacks," Mr Peters said.

"New Zealand will continue to stand with the international community in support of maritime security, including safe shipping lanes and the protection of civilian crews."
