I refer to your email of 12 February 2024 in which you request the following under the Official Information Act 1982 (OIA):

Under the OIA could you please provide me with a list of briefings that have been sent to the Minister of Foreign Affairs since 1 Jan 2024, up until 10th of Feb 2024.

Between 1 January 2024 and 10 February 2024, the Ministry of Foreign Affairs and Trade (the Ministry) sent 81 briefings to the Minister of Foreign Affairs. Please note that 6 of the briefings were referred to the Minister of Foreign Affairs by the Prime Minister, the Minister for Trade, the Minister of Defence, and the Associate Minister of Foreign Affairs respectively.

A list of briefings is attached in **Annex One**. Please note, 24 of the briefing titles are being withheld in full under one or more of the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government;
- 6(c): to prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial;
- 9(2)(g)(i): to protect the free and frank expression of opinions by departments;
- 9(2)(f)(iv): to protect the confidentiality of advice tendered by Ministers of the Crown and officials;
- 9(2)(h): to maintain legal professional privilege; and
- 9(2)(j): to avoid prejudice to negotiations.
