6. Vanuatu is extremely vulnerable to the impacts of natural disasters and climate change. It experiences severe cyclones, drought, as well as periodic volcanic eruptions. In 2023 it was hit by three significant cyclones (Category 4 or 5), including two within one week in March. New Zealand provided relief supplies and disaster management experts to help Vanuatu in responding to cyclones.

New Zealand's bilateral development assistance to Vanuatu in the last triennium (2021-24) was NZ\$103 million – one of our largest. It is a broad programme, including energy and water, tourism, education, security and governance. ^{s6(a)}

6. Vanuatu was the first country to engage in RSE. Today Vanuatu is the single largest contributor of workers to New Zealand's RSE scheme with over 6,000 ni-Vanuatu workers per year working in mostly the horticulture industry (40% of our RSE workforce).

7. Vanuatu recently held its first referendum (since independence in 1980) which approved constitutional changes designed to strengthen the political party system and reduce the floor-crossing by individual MPs $^{s6(a)}$

New Zealand is supporting Vanuatu-led reforms to its electoral systems and provided support to the referendum – through an arrangement with the UN Development Programme.

8. In July, Vanuatu released its first comprehensive foreign policy paper. The document formally confirmed Vanuatu's long-stated "friends to all, enemies to none" and non-aligned positioning, and prioritised addressing the existential threat of climate change ^{s6(a)}

included "human rights, democracy, and the rule of law" as underpinning values. It formally confirmed Vanuatu's view that New Zealand has "consistently been a highly-valued diplomatic, economic, development, and security partner".

9. The document described "geopolitical uncertainty" in the region as testing the robustness and resilience of Vanuatu's long-held foreign policy positions and relationships. However, it also reiterated Vanuatu's view that competition in the Pacific provides an opportunity to leverage "our new-found strategic relevance into tangible development gains for our people".
