Thank you for your email of 15 August 2024 in which you request the following under the Official Information Act 1982 (OIA):

- 1. Any current formal agreements (Terms of Reference) between the Ministry of Foreign Affairs and Trade and 1) Te Taumata, 2) Ngā Toki Whakarururanga, and FOMA;
- 2. Copies of whatever engagement agreements between Ministry of Foreign Affairs and Trade and individual members of Te Hurumanu; and
- 3. Copies of any Research, Analysis and Advice provided by each of 1) Te Taumata, 2) Ngā Toki Whakarururanga, FOMA and Te Hurumanu to the Ministry of Foreign Affairs and Trade over the last 2 calendar years 2022-23, and 2023-24.

You also provided the additional context below:

It appears that MFAT is wasting significant sums (\$NZ100,000's and even \$NZmillions) of taxpayers monies at a time when people across the economy are doing it hard and the taxpayers are getting Zero Return on Investment (nothing meaningful) on these taxpayers monies. If correct these groups should be disbanded immediately in line with the Governments austerity program impacting 1,000's of New Zealanders across the Board.

I intend getting to the bottom of this waste of Taxpayers monies for I suspect Zero Return on Investment. And then blow the whistle on this waste publicly.

## **Question Three**

We have interpreted the timeframe for the third part of your request to be from 15 August 2022 to 15 August 2024, the two-year period immediately prior to your OIA request.

For the period 15 August 2022 to 15 August 2024, a significant amount of research, analysis and advice has been provided to the Ministry by Te Taumata, Ngā Toki Whakarururanga, FOMA and Te Hurumanu. Therefore, we are refusing this part of your request under section 18(f) of the OIA, as the volume of advice received is too large and spans too many formats and platforms and as such, cannot be made available without substantial collation and research.

For the period requested, 104 meetings were held with members of either Te Taumata, Ngā Toki Whakarururanga, FOMA or Te Hurumanu. These meetings range in duration and provide rich feedback and advice on a variety of trade policy issues, including active issues and negotiations as they are undertaken by the Ministry.

In the case of Te Hurumanu, this group works in partnership with Ministry officials. Consequently, advice from members of Te Hurumanu is intertwined in all documents and work of this group.

Ngā Toki Whakarururanga and their members submit some of their analyses and examinations directly to the Foreign Affairs, Defence and Trade Parliamentary Select Committee, with the support of Ministry funding.
