Please see the following table for a breakdown of actual International Development Cooperation (IDC) programme expenditure benefitting Tokelau by financial year over the twenty-year period 2004/05 to 2023/24. This includes expenditure on budget support, projects, technical assistance, scholarships and training, and humanitarian assistance. It includes both bilateral and multi-country activities. For multi-country activities, only the Tokelau proportion of the activity is reflected.
