Thank you for your email of 1 April 2025 in which you request the following under the Official Information Act 1982 (OIA):

"all advice, briefings, reports, memos and similar correspondence between mfat and the office of Winston Peters regarding his trip to New York and Washington this year as well as •all advice, briefings, reports, preparatory documents and similar correspondence regarding the change in US Administration including how Peters can prepare for the change to a Donald Trump presidency"

On 10 April 2025, the Ministry of Foreign Affairs and Trade (the Ministry) contacted you to advise that the scope of this request was very broad, and likely to be refused under section 18(f) of the OIA, as the information requested cannot be made available without substantial collation or research. On the same day you agreed to refine the scope of your request to be for:

"Formal advice to the Minister of Foreign Affairs regarding his visit to New York and Washington in March 2025"

On 14 May 2025, the timeframes for responding to your request were extended by an additional 22 working days because responding to your request necessitated the review of a large quantity of information (section 15A(1)(a) of the OIA refers). Attached are the following documents that are in scope of your request:

- 1. Minister of Foreign Affairs Day Packs United States Visit 13-19 March, dated 13 March 2025
- 2. Meeting Brief: Bilateral Meeting with Secretary of State Marco Rubio, dated 12 March 2025

Some information is withheld under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government; and
- 9(2)(a): to protect privacy.

Where the information has been withheld under section 9 of the OIA, no public interest in releasing the information has been identified that would override the reasons for withholding it.

President Trump is imposing tariffs on trade competitors, starting with heavy tariffs on neighbours Canada and Mexico. The EU and China are also clearly in the cross hairs, as potentially are all trade partners, including New Zealand, and we anticipate further tariff announcements in the next weeks and months. These may affect New Zealand either directly – for example the announced tariffs on all agricultural imports from 2 April – or indirectly, through the disruption to international supply chains. s6(a)

President Trump delivered his first address to Congress in his second term on Tuesday 4 March. His address primarily recounted his actions enacted in his first weeks in office. He focused on his overhaul of the federal government, actions to counter illegal immigration, and promises of tax relief.

Trump defended the tariffs implemented that day including against Canada, Mexico, and China. He foreshadowed reciprocal tariff action on 2 April, including the possibility of greater tariffs on agricultural products, and called out close partners such as the Republic of Korea for perceived unfair treatment of the US. He made a rare acknowledgement that his tariff programme would require an "adjustment process" and be a "little disruptive".

Trump signalled his desire to maintain channels of communication with the Ukrainian and Russian presidents and arrive at a peace plan to resolve the war in Ukraine. Trump did not signal his intentions in detail for the Middle East, for Congress, and any desire for bipartisan cooperation in his and ward of the official of th address. Democrats protested throughout the address and warned of the high costs that Trump's policies would impose in their formal response.



Dr Richard Haass is the Senior Counselor with Centerview Partners – a US investment banking firm that provides strategic advice and consultancy services. Haass is a veteran diplomat and remains a President Emeritus of the Council on Foreign Relations, where he served until 2023 as President for 20 years.

Haass was US State Department Director for Policy Planning and a principal adviser to Secretary of State Colin Powell. He also served as US Coordinator for Policy Towards the Future of Afghanistan and US Envoy to the Northern Ireland Peace Process. He retains the rank of Ambassador.

He holds a bachelor's degree from the University of Oberlin, a PhD from Oxford University, and honorary degrees from Harvard University. He is a New York native and is married to Susan Mercandetti. They have two children.

**Philemon Yang** [Appropriate address: "**Mr President**"] is the current President of the General Assembly (PGA) for the 79<sup>th</sup> session (2024–25), the neutral facilitator for the Assembly's deliberations. Yang is a former Prime Minister of Cameroon (2009-2019).

Born in 1947, Yang is a magistrate by training. After obtaining a law degree in Cameroon, Yang completed a Master of Laws (International Law) from the University of Ottawa, and a Master of Business Administration from US Century University.

He has previously held Ministerial portfolios in Cameroon including, Vice-Minister of Territorial Administration (1975-79) and Minister of Mines and Energy (1979-84). He also served for 14 years as Cameroon's High Commissioner to Canada (1984-2004).

Not surprisingly, given Yang's background, the focus for his presidency is sustainable development and advancing "Agenda 2063: The Africa We Want". Yang has also prioritised: Al and digitalization; finance, science and technology; revitalisation of the work of the General Assembly; and work to combat climate disruption.

Yang has visited Australia for a CHOGM meeting but is only lightly familiar with our region. He is married and has three children.

# Meeting Brief: Rosemary DiCarlo, Under-Secretary-General for Political and Peacebuilding Affairs

**Rosemary DiCarlo** [Pronounced dee-car-low; appropriate address: "**Under-Secretary-General**"] is the Under-Secretary-General for Political and Peacebuilding Affairs, one of the most senior roles in the UN Secretariat. A US national, DiCarlo assumed the post in 2018.

She advises the UN Secretary-General on international peace and security issues and frequently briefs the UN Security Council on conflict situations. She oversees "good offices" initiatives and field-based political missions carrying out peace-making, preventive diplomacy and peace-building activities. She also oversees UN electoral assistance provided to dozens of member states each year.

During her previous career with the US Department of State, DiCarlo served as the US Deputy Permanent Representative to the UN (appointed under President Obama). Other assignments included Deputy Assistant Secretary of State for European and Eurasian Affairs, and Director for UN Affairs at the National Security Council, in D.C. She has completed overseas postings to Moscow and Oslo.

She was President of the National Committee on American Foreign Policy (2015-2018) and was concurrently appointed a Senior Fellow and Lecturer at Yale University's Jackson Institute for Global Affairs.

DiCarlo graduated from Brown University with a BA, MA and PhD in comparative literature, Slavic languages and literature. She speaks French and Russian. We understand she may be travelling the week after you meet to Brussels with SG Guterres for NATO discussions.

DiCarlo and HOM NYK served as Deputy Permanent Representatives together, including during New Zealand's term on the UN Security Council in 2015-16.

**Bob Rae** [appropriate address: "**Ambassador**"] is Canada's Permanent Representative to the UN in New York. He has served in this post since August 2020. Rae is active across the UN agenda, including as the President of the Economic and Social Council (ECOSOC) for 2024-25.

Rae served as Premier of Ontario from 1990 to 1995, and interim Leader of the Liberal Party of Canada from 2011 to 2013. Rae is closely affiliated with the Trudeau government.

The son of a diplomat, Rae received a BA in Modern History from the University of Toronto, an MPhil in Politics as a Rhodes Scholar at Oxford University and graduated from the University of Toronto Faculty of Law in 1977. He served as assistant to the Canadian General Counsel of the United Steelworkers from 1975-77. He was named a Queen's Counsel in 1984.

Waltz was a Senior Advisor and Policy Director for South Asia and Counterterrorism at the Pentagon in the George W. Bush White House.

Waltz is a Distinguished Military Graduate of the Virginia Military Institute. He served as a Special Forces officer on active and reserve duty with the US Army with multiple tours in Afghanistan and in Europe, Africa, and the Middle East.

Waltz was formerly Chief Executive Officer of Metis Solutions, which provides strategy, intelligence, and operational support to US government customers worldwide. Sebastian Gorka is Deputy Assistant to the President and Senior Director for Counterterrorism.

Sebastian Gorka is British born with Hungarian heritage. He lived in Hungary from 1992-2008, where he maintained a good relationship with Prime Minister Viktor Orbán and was briefly Vice-President of the Hungarian Democratic Forum, a now-defunct right-wing party.

In 2008 he moved to the United States with his American wife, where he established himself as a military and intelligence analyst. He was a high-profile commentator in right-wing publications, on radio and TV.

Gorka played an active role in Donald Trump's first presidential campaign and in 2017 was appointed as a national security adviser to the President.

Between presidencies, Gorka remained a staunch supporter of Trump through his radio show, *America First*, his podcast, and frequent appearances on cable news channels such as Fox. In 2022 he filed a lawsuit against the House Select Committee investigating the 6 January 2021 events at the Capitol, after it sought access to his phone records.
