Thank you for your email of 28 October 2025, transferred from the Minister of Foreign Affairs on 31 October 2025, in which you request the following under the Official Information Act 1982 (OIA):

"Please provide all emails/ briefings sent or received by the Minister to/from officials at MFAT containing the word 'Haskel' or 'Haskel-Harpaz', or 'Sharren' in the months of August, September and October 2025."

Please see attached the information in scope of your request. Some information is withheld under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government;
- 6(b)(i): to protect the passing of information from another government on a confidential basis;
- 9(2)(a): to protect individuals' privacy;
- 9(2)(g)(i): to protect the free and frank expression of opinions by departments, and;
- 9(2)(g)(ii): to protect officers and employees from improper pressure or harassment.

One of the email chains in scope of your request relates to the drafting of a Written Parliamentary Question, and the draft response is withheld in full under section 9(2)(g)(i) of the OIA, to protect the free and frank expression of opinions by departments. One of the email chains in scope of your request related to the drafting of an Oral Parliamentary Question. For your visibility, I've just had a voice message from the Israeli Ambassador to let me know that it is possible the Israeli Deputy Foreign Minister Sharren Haskel ^{s6(a)} will look to visit New Zealand later this year

Earlier this afternoon, we had a media inquiry from RNZ about whether she was planning to visit, as part of a wider trip to the Pacific. This was prior to the Ambassador's message and we advised we (MFAT) were not aware. We've just spoken to MEDIA which has confirmed that they haven't responded to RNZ yet.

We don't have any further details at this stage – the Ambassador's note to us may have been promoted by a similar RNZ inquiry. We propose that MEDIA respond:

MFAT has been advised by the Israeli Embassy that the Deputy Foreign Minister has expressed interest in visiting New Zealand later this year. We have no further details at this stage.

on the visit, and directed them to the Israeli Embassy. The Israeli Embassy has advised
us of the transit by TPN but not formally requested any Ministerial calls. We have also

explained that she does not have a counterpart. Let me know if you have any further questions. s9(2)(g)

Talking points:

- We have been advised that the Israeli Deputy Foreign Minister Sharren Haskel will be transiting Auckland in late October, on her way to the Pacific.
- No meetings have been scheduled with New Zealand Ministers or officials.
- Questions on the Deputy Minister's travel plans should be directed to the Israeli Embassy.

If asked talking points:

- *Why isn't she being denied a visa?*
 - o She is not one of the two Israeli Ministers banned from travel to New Zealand.
- *Why are you not meeting her at Ministerial level?*
 - o She is transiting and we have not been approached to make this an official visit to New Zealand. Moreover, the Deputy Minister does not have a counterpart in New Zealand.
- *Will officials meet her?*
 - o No meetings with officials have been scheduled.
- *What is the time and date she will be visiting?*
 - o Questions on the Deputy Minister's travel plans should be directed to the Israeli Embassy.

Background:

Israeli Deputy MFA Sharren Haskel will transit Auckland **from 1.40pm-9.10pm on Thursday 23 October**. She is travelling on an official visit to a number of Pacific Island Countries. We understand she will be meeting with the Jewish and Israeli community in Auckland during her transit.
