Thank you for your email of 14 October 2025, in which you request the following under the Official Information Act 1982 (OIA):

"Under the Official Information Act I am requesting MFAT internal emails regarding the detention and treatment of New Zealand citizens on the ship 'Conscience', part of a flotilla that attempted to make its way to Gaza"

On 12 November 2025, the timeframes for responding to your request were extended by an additional 10 working days because responding to your request necessitated the review of a large quantity of information (section 15A(1)(a) of the OIA refers).

Attached is the information in scope of your request. There were multiple out of scope emails contained in an email chain, so these have been removed for administrative ease. Some information is withheld under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government;
- 6(b)(i): to protect the passing of information from another government on a confidential basis;
- 9(2)(a): to protect individuals' privacy; and
- 9(2)(g)(ii): to protect officers and employees from improper pressure or harassment.

Where the information has been withheld under section 9 of the OIA, no public interest in releasing the information has been identified that would override the reasons for withholding it.

Please note that it is our policy to proactively release our responses to official information requests where possible. Therefore, our response to your request (with your personal information removed) may be published on the Ministry website: www.mfat.govt.nz/en/about-us/contact-us/official-information-act-responses/

- The $^{s6(a)}$ Consul gave $^{s9(2)(a)}$ the opportunity to $^{s9(2)(a)}$
- He was also offered the chance to call and talk to the New Zealand Consul in Ankara, s9(s9(2)(a), s9(2)
- While I have extended thanks here through informal means for the assistance provided by colleagues in providing consular and logistical support to New Zealanders, WLN may also wish to extend thanks to the embassies of s6(a) at some point.

Good evening

The ^{s6(a)} Consular team visited Ketziot today and were able to meet with ^{s9(2)(a)} They will send a report later but below are the points for this update:

- s9(2) is ok but mentioned aggressive behaviour from the authorities once the group arrived at port and that they were handcuffed and blindfolded all the way from the port to Ketziot.
 He said that the conditions in the detention centre are bad especially the water, toilets and beds.
- s9(2)(a) is currently on the manifest for a
 Turkish charter flight to Istanbul tomorrow departing Israel at s9(2)(a)

We assume, but do not know for certain, that the flight will go to Istanbul airporton the European side, not Sabiha Gokcen airport on the Asian side.

there may not be the level of support in booking accommodation and flights for $^{^{\mathfrak{sg}(2)(a)}}$ and others when they reach Istanbul.

- I've contacted consular colleagues in Ankara to let them know about the flight and to check what support they will be offering their nationals on arrival in Istanbul.
- There is a hotel at Istanbul airport, the Yotel which s9(2)(a)

There are also three Western Union agents at the airport for transferring funds. There are other hotels nearby, but some form of payment for transport would be required to get to these places (or they could talk to the hotel about including an airport transfer in the cost of any booking). The issue will be maintaining contact with $^{\mathfrak{sg}(2)(a)}$ once in Istanbul if $^{\mathfrak{sg}(2)(a)}$

Thanks \$9(2). A quick update below so we're all up to date. I'll provide another update this evening, but don't expect there to be much to add until there have been visits.

- Israel authorities have confirmed the process will be the same as with the Sumud. The
 boats are currently en route to Ashdod port where the passengers will be processed and
 then transferred to Ketziot where consular visits will be facilitated, likely starting tomorrow
 (Thursday). Embassies are not permitted at the Port but with the Sumud, the lawyers were
 able to meet with flotilla members there so this may be the case again this time.
- I had already given the ^{s6(a)} a heads up about ^{s(2)(a)}, through what we knew in the news article. I have clarified that there is only one NZer and requested their assistance again. This shouldn't be an issue.
- I've been in contact with the ^{s6(a)}
 They have offered support as well. I will keep in touch with them to see if ^{s9(2)(a)} can move with ^{s9(2)(a)} if they have news of a deportation before we do.
- I have let Israel MFA know we are aware of one NZer on board the Conscience and that we have requested assistance again from the s6(a) in providing consular support when visiting Ketziot.

Providing an update on developments overnight on the 1000 Madleens Flotilla, and updated media lines:

Developments overnight

- Disembarkation of flotilla participants has commenced at Ashdod port in Israel, and processing will likely go on through
 the night. Embassies are not permitted at the port. Lawyers may be able to meet with flotilla members at the port, as they
 did with the Sumud flotilla, although this is not certain.
- We expect a similar process to the Sumud flotilla, that participants will be deported quickly. At this stage we don't know where to, but we will seek further information on deportation plans.
- The S6(a) has confirmed they will provide consular support for any NZ nationals who are part of the 1000 Madleens flotilla.
- ANK has also been in contact with the \$6(a)
- ANK has informed the Israeli Ministry of Foreign Affairs that we are aware of one NZer on board the Conscience, and that
 we have requested assistance again from the s6(a) Embassy in providing consular support when visiting Ket'ziot.
- While the Israeli Ministry of Foreign Affairs has indicated appointments will have to be approved before visits to
 detainees at the Ketziot detention facility, \$6(a)

 Many Embassies are
 saying that they will go to Ket'ziot in the morning (Thursday morning local time) \$6(a)
- This is similar to what happened with the Sumud passengers.
