# Investme Proposed Overseas Travel: Hon Todd McClay - May/June 2025

Portfolio Trade and Investment

On 26 May 2025, Cabinet:

- authorised the absence of Hon Todd McClay from New Zealand from 29 May to 1 8 June 2025, to travel to:
  - Switzerland to attend the Future of Investment and Trade Partnership Ministerial 1.1 Meeting;
  - Paris, France to lead New Zealand's delegation at the Organisation for Economic 1.2 Cooperation and Development Ministerial Council Meeting and undertake bilateral meetings;
  - 1.3 Brussels, Belgium s6(a)
- 2 agreed that he be accompanied by one member of staff;
- approved the estimated expenditure of up to \$44,570.40 for the travel expenses of the 3 Ministerial party as a charge to Vote Internal Affairs (Members of the Executive - Travel);
- noted that he will also be accompanied by officials from the Ministry of Foreign Affairs and 4 Trade, whose travel costs will be met by their agency:
- 5 agreed that in his absence:
  - Hon Andrew Hoggard act as Minister of Agriculture;
  - 5.2 Hon Simon Watts act as Minister of Forestry;
  - 5.3 Hon Nicola Grigg act as Minister for Trade and Investment;

#### Proposed Overseas Travel: Hon Todd McClay – May/June 2025

- 1 I seek approval to travel to Switzerland, France and Belgium from 29 May to 8 June, in my capacity as Minister for Trade and Investment.
- 2 The Chief of Staff has approved the travel in-principle, and leave has been approved by the Party Whip.

#### Purpose of Travel

- 3 In Switzerland I will attend the Future of Investment and Trade Partnership (FIT-P) Ministerial Meeting with my Swiss, Singaporean, and UAE counterparts,<sup>s6</sup>(a)
- 4 In Paris I will lead New Zealand's delegation at the Organisation for Economic Cooperation and Development (OECD) Ministerial Council Meeting (MCM) over 2-4 June. Through the OECD we address common global challenges and promote good governance in both public and private sectors.
- 5 I will also meet with my trade counterparts in bilaterally and in smaller Ministerial groupings where I intend to progress key trade objectives. I will also seek meetings with French counterparts and engagements with French businesses who have interests in stepping up their investment in New Zealand.
- 6 In Brussels, s6(a)

: I will

also seek meetings with EU representatives and host a reception attended by New Zealand business, their European business partners, and key EU officials to celebrate the first year of the EU FTA in force.

I will be accompanied by one staff member from my office, and officials from the Ministry of Foreign Affairs and Trade (MFAT). All costs for MFAT staff will be covered from within the Ministry's baseline budget.
