Report on Overseas Travel: Rt Hon Winston Peters - 1-2 May 2025

This paper recommends that Cabinet note this report on recent travel to Noumea, New Caledonia over 1-2 May 2025.

Report

- This travel our second visit to New Caledonia in five months was evidence of New Zealand's prioritisation of regular political-level visits to maintain relationships s6(a) in the Pacific. We had been invited to visit New Caledonia at this time by the French Minister for Overseas Territories, Manuel Valls, who was in-country for negotiations on New Caledonia's institutional future.
- The visit was therefore a well-timed chance to engage with the new leadership of the Government of New Caledonia (President Alcide Ponga) and the third-most senior minister serving under French President Emmanuel Macron. This served to demonstrate and reinforce New Zealand's commitment to engaging constructively with both the New Caledonian people and the French Government to support New Caledonia's pathway forward, following last year's civil unrest. This is especially important given New Caledonia is geographically New Zealand's closest neighbour.

engagements, we reiterated New Zealand's desire to provide constructive support to New Caledonia and France s6(a)

- The visit also enabled us to explore New Zealand's proposal for a delegation of Caledonian entrepreneurs to visit New Zealand to learn about Māori economic development. s6(a) the study tour was endorsed by both Minister Valls and President Ponga and the visit will now take place this week (30 June-4 July 2025).
