Report on Overseas Travel: Hon Nicola Grigg – 17-18 July 2025

I recommend that Cabinet note this report on my travel to Suva, Fiji, from 17 to 18 July 2025 to attend the biennial Pacific Islands Forum Trade Ministers Meeting (FTMM) and undertake bilateral engagements.

Report

- The purpose of my travel to Fiji was to represent New Zealand at the FTMM in my capacity as Minister of State for Trade and Investment. Attendance at ministerial level reinforced New Zealand's commitment to regional economic integration, with the Pacific Islands Forum (PIF) at the centre of our approach, and our support for regional trade architecture and Pacific resilience.
- 2 A key outcome of the meeting was a Joint Ministerial Statement. s6(a)

The meeting was also an opportunity to demonstrate New Zealand's commitment to advance Pacific trade priorities such as:

- 2.1 The international trade landscape and the central role of the World Trade Organization (WTO) in maintaining a fair and predictable trade environment. I emphasised New Zealand's ongoing commitment to the rules-based trading system and encouraged Forum Members to accept the WTO Agreement on Fish Subsidies and continue negotiations on Additional Provisions to this Agreement. I also highlighted the funding available to Pacific members via the WTO Fish Fund to implement the WTO Agreement on Fish Subsidies, once accepted. New Zealand has contributed NZ\$310,000 to this fund.
- Trade Ministers endorsed the Pacific Aid for Trade strategy, granted the PACER Plus Implementation Unit observer status at future Trade meetings. PACER Plus remains a cornerstone of the region's trade as the region's only reciprocal, comprehensive trade agreement, and observer status will further help with the unit's visibility and connectivity.
- 2.3 No consensus was reached on Pacific Labour Mobility Principles or the proposed Kava Declaration. Ministers agreed further work is needed. s6(a)

New Zealand remains committed to supporting the Pacific's kava sector, including via PHAMA Plus and continued access

to our market. Pacific Trade Invest estimates the global kava market at US\$1.5–2 billion, driven by rising demand in Australia and the United States.

- In the margins of the FTMM, I participated in a trilateral meeting with Fiji's Deputy Prime Minister (DPM) and Minister for Trade, Cooperatives, SMEs and Communications, Manoa Kamikamica, and Australian Assistant Minister for Pacific Island Affairs, Senator Nita Green. In this meeting I highlighted the value New Zealand places on Fiji's potential accession to the regional PACER Plus trade agreement and encouraged Fiji to continue considering accession.
- While in Fiji, I advanced the Government's Going for Growth agenda by attending the launch of the Fiji New Zealand Business Council's strategy to increase two-way trade to NZ\$2 billion by 2030 (a target set by our two Prime Ministers in June 2024). The launch event provided a platform to reinforce to Fiji businesses how PACER Plus would lock in market access to seven of Fiji's top ten markets and would bolster economic resilience.
- My attendance also enabled conversations related to my Women portfolio, including a discussion with Fiji's Women, Children and Social Protection, Minister Kiran on the challenges affecting women and children in Fiji and the wider region. It also enabled a helpful sharing of views on the upcoming PIF Women Leaders Meeting (held in Fiji 22-25 July).
