Report on Overseas Travel: Rt Hon Winston Peters – 23-31 May 2025

This paper recommends that Cabinet note this report on travel to Australia, Sri Lanka, Nepal, and India from 23-31 May 2025 in order to undertake bilateral engagements.

Report

- The purpose of travel to Australia was to conduct six-monthly Australia-New Zealand Foreign Ministry Consultations and engage early with the reelected Australian Government at a senior level, in order to promote New Zealand's priority interests in our bilateral relationship and enhance our coordination in support of shared international goals such as Pacific development and security.
- The purpose of travel to Sri Lanka and Nepal was to highlight the New Zealand Government's commitment to energising its relationships in South Asia, reinforce the long-standing nature of our relationships, and emphasise New Zealand's interest in maintaining and strengthening dialogue and cooperation.
- The visit to Nepal was the first by a New Zealand Foreign Minister. It emphasised New Zealand's interest in deepening cooperation with Nepal on our shared interests in the multilateral system, in particular on UN reform and upholding the rules based international system.
- The purpose of travel to India was to underline New Zealand's commitment to developing a broad-based relationship, s6(a)

Bilateral visit to Australia, 23-24 May

- Discussions with Minister Wong provided a valuable opportunity to profile New Zealand as an indispensable partner s9(2)(g)(i)

- While in Melbourne the Minister also held television interviews with Sky News Media and ABC Media, raising the profile of New Zealand's foreign policy settings and our close partnership with Australia.

Bilateral visit to Sri Lanka, 24-28 May

- In Sri Lanka, Minister Peters met with key figures in the new government: President Anura Kumara Dissanayake, Prime Minister Harini Amarasuriya, and Foreign Minister Vijitha Herath, as well as Leader of the Opposition Sajith Premadasa.
- The visit, the first of a New Zealand Foreign Minister since 2013 and the establishment of a High Commission in Colombo in 2021, achieved the primary objective of profiling New Zealand as a reliable, constructive, and invested partner, and affirming our commitment to maintaining the long-standing bilateral relationship with the new government.
- Discussions elicited useful proposals for strengthening bilateral cooperation, including holding Foreign Ministry Consultations in 2026, s6(b)(i) and strengthening bilateral dialogue on trade.
- The visit allowed us to convey New Zealand's credentials as an invested and valuable partner in Sri Lanka's development ambitions, including through our development cooperation and support for the growth of sustainable tourism in Sri Lanka.

Bilateral visit to Nepal, 28 - 29 May

- 17 Minister Peters met with President Ramchandra Paudel. In Nepal, Prime Minister K P Sharma, and Foreign Minister Rana Deuba, as well as Leader of the Opposition and former Prime Minister Pushpa Kamal Dahal. S
- The visit successfully reaffirmed the warm and friendly relationship between 18 New Zealand and Nepal and New Zealand's intent to maintain this.
- inisterior New Zealand confirmed at the highest levels our shared interest in reform and 19 strengthening of the multilateral system.

- Ministers discussed the breadth of the relationship, including: the importance of the defence and security relationship; Free Trade Agreement negotiations; and opportunities for collaboration across education, sports, traditional medicine, and digital payment systems.
- Ministers also discussed a number of regional matters, s6(a), s6(b)(i)
- 27 Minister Peters delivered a keynote Foreign Policy speech surveying New Zealand's underlying foreign policy philosophy, our relationship with India, and our approach to the Indo-Pacific generally. The speech was hosted by the Ananta Aspect Centre (a leading New Delhi-based think tank) to an audience of Indian thought-leaders, officials, commentators, and media.
- Minister Peters also met with JP Nadda, President of the Bharatiya Janata Party and Minister of Health and Family Welfare, and Rahul Gandhi, Leader of the Opposition.
