Thank you for your email of 2 December 2025, in which you request the following under the Official Information Act 1982 (OIA):

*"I am writing to request the following information from MFAT under the Official Information Act 1982 regarding New Zealand citizens currently held in prisons overseas.*

*Please provide, for the most recent date available (or as at 1 December 2025 if a specific snapshot date is required by your system):*

1. *The total number of New Zealand citizens imprisoned overseas, broken down by:*
  - *Country*
  - *Gender*
  - *Whether they are on **remand** or **sentenced***
2. ***If recorded***, *please also provide the **length of time** each individual has been detained or, if this cannot be released at an individual level, please provide:*
  - *Aggregate time bands (e.g., under 1 year, 1-3 years, 3-5 years, 5+ years), broken down by country.*
3. ***If MFAT does not hold all of this information***, *please clarify:*
  - *What information is held*
  - *What information is available only at an aggregate level*

*What information is not collected or cannot be released for privacy or diplomatic reasons."*

Information relevant to your request can be found in **Appendix one** and is also provided in PDF format (attached). Where totals were fewer than five, the data has been withheld or aggregated into broader regional groupings to protect privacy and maintain data reliability.

Please note this is not a complete list of all New Zealanders in detention overseas, as New Zealanders may choose not to advise the New Zealand Government of their detention, as is their right under international law.
