On 28 October 2021, the Cabinet Legislation Committee:

- **noted** that on 9 August 2021 the Petitions Committee referred Vadim Chausov's petition 1 titled "Solidarity with the people of Belarus and support for democratic aspirations" to the Minister of Foreign Affairs for response;
- noted the submission of the Minister of Foreign Affairs and in particular her advice that: 2
 - 2.1 New Zealand shares protesters views that the elections on 9 August 2020 were neither free nor fair;
 - 2.2 New Zealand regularly encourages Belarusian authorities to begin a reliable process for reconciliation and free and fair elections;
 - New Zealand uses multilateral for to regularly condemn the state sponsored actions 2.3 of Belarusian security forces towards civilians;
 - 2.4 New Zealand suspended all high level bilateral political (ministerial and ambassadorial) engagement, as well as defence and military engagement with Belarus:
 - New Zealand has travel bans in place against over 70 individuals associated with the Lukashenko regime;
- approved the government response, attached to the submission under LEG-21-SUB-0175, to Vadim Chausov's petition entitled "Solidarity with the people of Belarus and support for democratic aspirations";
- **noted** that the government response must be presented to the House by 1 November 2021;

Government Response to the Referral of Vadim Chausov's Petition on "Solidarity with the people of Belarus and support for democratic aspirations"

Proposal

This paper seeks approval of the government's response to the Petition Committee's referral of Vadim Chausov's petition on "Solidarity with the people of Belarus and support for democratic aspirations".

Background

- 2 The petition requests that the New Zealand Government:
 - 2.1 Express solidarity with the people of Belarus and urge the government to support democracy:
 - 2.2 Condemn state sponsored violence and police brutality in Belarus; and
 - 2.3 Impose sanctions against those responsible for human rights violations in Belarus.

Government response

- 3 The government response outlines that:
 - 3.1 New Zealand shares protesters views that the elections on 9 August 2020 were neither free nor fair.
 - 3.2 New Zealand regularly encourages Belarusian authorities to begin a reliable process for reconciliation and free and fair elections;
 - 3.3 New Zealand uses multilateral fora to regularly condemn the state sponsored actions of Belarusian security forces towards civilians.
 - 3.4 New Zealand suspended all high level bilateral political (ministerial and ambassadorial) engagement, as well as defence and military engagement with Belarus, in response to the severe human rights violations administered by Belarusian police and security forces.
 - 3.5 New Zealand has travel bans in place against over 70 individuals associated with the Lukashenko regime, that prevent them from obtaining visas to enter or transit New Zealand. As a Member State of the United Nations, New Zealand implements sanctions when they are mandated by the United Nations Security Council.

Recommendations

The Minister of Foreign Affairs recommends that the Cabinet Legislation Committee:

Government response to Referral of Vadim Chausov's Petition On "Solidarity with the people of Belarus and support for democratic aspirations"

Introduction

- The government has carefully considered the Petition Committee's referral of the petition entitled "Solidarity with the people of Belarus and support for democratic aspirations". The petition requests that the New Zealand Government;
 - 1.1 Express solidarity with the people of Belarus and urge the government to support democracy;
 - 1.2 Condemn state sponsored violence and police brutality in Belarus; and
 - 1.3 Impose sanctions against those responsible for human rights violations in Belarus.
- The government welcomes the Committee's referral of this petition and thank the petitioner for bringing this matter to the government's attention.
- The government responds to the report in accordance with Standing Order 380.
- The government has considered the petition as it pertains to New Zealand's existing foreign policy settings, as well as our obligations and responsibilities under international law

Requests and government response

- 5 **Request 1:** That the New Zealand Government express solidarity with the people of Belarus and urge the government to support democracy.
- Response: New Zealand shares protesters views that the elections on 9 August 2020 were neither free nor fair. The New Zealand Government views free and fair elections, freedom of expression and freedom of peaceful demonstration as fundamental and inalienable human rights that must be upheld globally. This is in line with New Zealand's values based foreign policy approach.
- New Zealand routinely joins and delivers statements at the UN Human Rights Council (UNHRC), conveying our distress at the human rights environment in Belarus, supporting the democratic aspirations of the Belarusian people, and encouraging Belarusian authorities to begin a reliable process for reconciliation and free and fair elections. Our most recent statement was given at the 47th session of the UNHRC, in July 2021.

- 8 **Request 2:** That the New Zealand Government condemn state sponsored violence and police brutality in Belarus.
- 9 **Response:** The New Zealand Government is deeply concerned by the Belarusian authorities' ongoing severe human rights abuses against peaceful protesters, opposition, civil society and media, following the elections on 9 August 2020.
- New Zealand uses multilateral fora to regularly condemn the state sponsored actions of Belarusian security forces towards civilians. New Zealand participated in the Universal Periodic Review on Belarus in November 2020, where we recommended Belarus undertake impartial investigations into credible reports of arbitrary detention and torture against peaceful demonstrators by Belarusian security forces.
- In April 2021, New Zealand suspended all high level bilateral political (ministerial and ambassadorial) engagement, as well as defence and military engagement with Belarus, in response to the severe human rights violations administered by Belarusian police and security forces. The New Zealand Government will only revise these settings if there is genuine improvement to the human rights environment in Belarus.
- 12 **Request 3:** That the New Zealand Government impose sanctions against those responsible for human rights violations in Belarus.
- Response: New Zealand has travel bans in place against over 70 individuals associated with the Lukashenko regime, that prevent them from obtaining visas to enter or transit New Zealand. The ban covers the President and key members of his administration, the Electoral Commission, businessmen, the police and other security forces. New Zealand officials continue to monitor the situation in Belarus and make additions to our travel ban list accordingly.
- As a Member State of the United Nations, New Zealand implements sanctions when they are mandated by the United Nations Security Council. This means we cannot apply economic sanctions to Belarus or Belarusian individuals.
- The New Zealand Government encourages businesses with an international presence to undertake commercial due diligence of their supply chains and customers to ensure they are informed about any risk and reputation issues attached to their offshore commercial relationships.
- Officials at the Ministry for Primary Industries and Ministry of Foreign Affairs and Trade are in the process of engaging with New Zealand companies who import Potash fertiliser from Belarus.
