it Chonix I recommend that Cabinet note this report on my travel to Bangkok from 7 to 13 September 2019, where I represented New Zealand at a Ministerial-level negotiating meeting of the Regional Comprehensive Economic Partnership (RCEP) free trade agreement and undertook bilateral calls in Thailand.

- 1 Once again, the RCEP Ministerial Meeting focussed on delivering progress on the pledge made by Leaders at the RCEP Summit in November 2018 - that countries were "determined to conclude a modern, comprehensive, highquality and mutually beneficial RCEP in 2019."

Bilateral programme

6 My visit provided a timely, useful opportunity to meet with my Thai Ministerial counterparts in the newly elected government, including Deputy Prime

Minister for Economic Affairs Somkid Jatusripitak and Agriculture Minister Chalermchai Sri-on. I also met with newly-elected Members of Parliament from across the political spectrum, with an interest in agriculture and/or economic issues.

In these meetings I underscored the importance that New Zealand places on regional and international architecture, including the conclusion of RCEP and S6(a)

During my visit I highlighted opportunities for dairy and agricultural cooperation, including in the context of New Zealand's Comprehensive Economic Partnership (CEP) with Thailand. S6(a)

As such, the New Zealand agriculture sector, particularly dairy, should not be viewed as a threat, but as a partner that can help Thai farmers to lift their capabilities.

The programme also included a site visit to Green Spot, a factory producing soy milk-based drinks that use dairy inputs from Fonterra, while Beca was also the engineering consultant for the development of the plant itself, an example of trade and service partnerships adding value in Thailand. I also attended the Taste of New Zealand Launch Event with partner Central Food Retail, a high-quality food retailer that supports premium New Zealand food and wine brands.
