Proposed Overseas Travel: Hon David Parker

Portfolio Trade and Export Growth

On 18 November 2019, Cabinet:

- authorised the absence of Hon David Parker from New Zealand from 23 to 27 November 1 2019, to travel to Seoul, South Korea with a business delegation on Air New Zealand's inaugural flight from Auckland to Seoul, for a series of trade and economic calls;
- 2 agreed that he be accompanied by one member of staff:
- approved the estimated expenditure of up to [59(2)(t)(iv)] for the travel expenses of the 3 Ministerial party as a charge to Vote: Internal Affairs (Members of the Executive – Travel);
- 4 **noted** that Air New Zealand will meet the costs of one-way business class airfares and two nights' accommodation in Seoul for the Ministerial party, and that the Minister will disclose this to the Registrar of Pecuniary and Other Specified Interests of Members of Parliament;
- 5 **noted** that he will also be accompanied by an official from the Ministry of Foreign Affairs and Trade, whose travel costs will be met by the Ministry;
- 6 agreed that in his absence:
 - Hon Damien O'Connor act as Minister of Trade and Export Growth; 6.1
 - Hon Chris Hipkins act as Attorney-General; 6.2
 - Hon Nanaia Mahuta act as Minister for the Environment;
- **noted** that the House is not sitting during his absence.

- I seek Cabinet approval to travel to Seoul with a business delegation for a series of trade and economic calls between 23-27 November.

- 2 The Prime Minister has approved the travel in-principle.

Purpose of Travel

- New Zealand's bilateral relationship with the Republic of Korea is mature and 3 warm. We share a strong friendship underpinned by historic defence ties. s6(a) This will be the first Trade Ministerial visit between New Zealand and Korea since the signing of the Korea New Zealand Free Trade Agreement in 2015 (KNZFTA).
- 4 The visit will s6(a) provide a valuable opportunity to develop and sustain momentum in the relationship and fulfil a number of bilateral objectives, and it will support engagement between New Zealand and Korea businesses. It will also complement the bilateral visit to the Republic of Korea by the Minister of Foreign Affairs, the Rt Hon Winston Peters, in October.
- s6(a) 5 in the current turbulent international climate, it is particularly important to engage with like-minded partners in the region to cooperate on protecting and promoting the rules-based order and international trade rules. In this regard, the Republic of Korea is a natural partner for New Zealand - our values and interests frequently align. s6(a) include our two Governments' similar domestic economic agendas, with a common focus on the future of work, people-centred growth and the development of well-being policies.
 - The visit will provide a forum to signal to a business audience some of New Zealand's key regional and bilateral economic interests, including: encouraging the Republic of Korea's accession to the Comprehensive and Progressive Trans-Pacific Partnership; and underlining our shared interest in supporting the World Trade Organisation and its reform. It will also provide an opportunity to advance shared objectives in New Zealand-Republic of Korea hydrogen cooperation, at both the private sector and government level, s6(a), s6(b)(i)
- 7 I will be travelling with a senior business delegation. The visit will serve to assist New Zealand companies to establish new, or advance existing, business opportunities with the Republic of Korea. The composition of the delegation

aligns with active opportunities the Korean market offers to New Zealand exporters; food and beverage (with an emphasis on dairy and horticulture); technology and specialised manufacturing.

8 The timing of my visit has been scheduled to allow me to travel with the business delegation on Air New Zealand's inaugural flight from Auckland to Seoul. As well as supporting the objectives of the business delegation, I will attend official events in Seoul to mark the occasion of the inaugural flight which will support growing people to people links and on-going efforts to raise the? profile of New Zealand as a tourism destination in the Korean market. Air New Zealand has developed its own quest list for the flight, and I will be meeting with these business and media representatives during my visit. Air New Zealand has gifted a one-way business class airfare each, for me and my staff member, and two nights' accommodation for the travel (I will be returning on another airline).
