Purpose of Travel

- 3 Zealand Expo- pavilion site location. The purpose of my visit is to check on the progress that is being made on the New Zealand Expo-pavilion site and to also meet the Minister of State for International Cooperation and Director-General, Dubai Expo 2020.
- The centrepiece of my visit to Europe is the attend the Commonwealth Trade 4 Ministers Meeting (CTMM) in London on 10 October. This will be the first CTMM for over a decade and will focus on identifying practical steps in delivering on the target set by Commonwealth Heads of Government Meeting (CHOGM) last year to lift trade and economic cooperation of Commonwealth countries to US\$2 trillion by 2030. It is my hope that the CTMM will deliver a strong statement in support of the WTO and multilateral trading system. I will also take the opportunity of being at the CTMM to meet with other key Ministers from Commonwealth countries to progress bilateral trade issues.
- 5 My visit to London will come at a turbulent time in the United Kingdom ahead of the 31 October Brexit deadline. I plan to hold meetings with key United Kingdom ministerial counterparts to discuss bilateral issues in both my environment and trade portfolios such as the Secretary of State for International Trade; Secretary for Department for Energy Food and Rural Affairs; Attorney General; and Secretary for Business Energy and Industrial Strategy. It is my hope that this ministerial engagement will help to enforce New Zealand's interests at a critical time for the United Kingdom ahead of the Brexit deadline.
 - My visit to London and Berlin will coincide with a visiting New Zealand International Business Forum (NZIBF) business delegation. I will take part in business support events for this delegation in both cities that will include a business support lunch event in both cities.
- 7 In Berlin my programme will also involve both my environment and trade portfolios. I will have meetings with the Environment, Nature Conservation and Nuclear Safety Minister and also the Federal Minister for Economic

Affairs and Energy and with Chancellor Merkel's Economic Policy Advisor and G20 Sherpa. I also intend to meet with the Parliamentary Select Committee for Economic Affairs and Energy and to have a dinner with the leadership of the German Greens to discuss environmental challenges and solutions.

8 During my time in Berlin I will take part in a roundtable discussion with environmental non-governmental organisations to share perspectives. I will also take part in a circular economy site visit to the ALBA Group, a leading -3KOW German recycling company.
