For the purposes of this Arrangement, all references in the Relationship Letters to TPP will mean references to CPTPP.

I have the honour to propose that this letter and your letter in reply confirming these understandings constitute an Arrangement between the Government of Malaysia and the Government of New Zealand, which will come into effect on the date on which the CPTPP enters into force for both Malaysia and New Zealand.”

I have the further honour to confirm that the above reflects the mutual understandings reached between the Government of Malaysia and the Government of New Zealand during the course of negotiations on the CPTPP, and that your letter and this letter in reply will constitute an Arrangement between the Government of Malaysia and the Government of New Zealand.


