For China, the term "non-party" under Article 5 (Most-Favoured Nation Treatment) of Chapter 9 (Trade in Services) shall not include the following WTO members within the meaning of the WTO Agreement: Hong Kong, China; Macao, China; and Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu (Chinese Taipei).
