- a) exchange information and discuss policies, regulations and actions related to trade in cosmetic products to identify opportunities for further cooperation;
- notify each other, through the contact points established in Article 100 of the Agreement, of changes to policies, regulations and standards related to cosmetic products that could significantly affect trade;
- c) cooperate to support the facilitation of trade in cosmetic products between New Zealand and China, including the reduction of barriers to trade affecting cosmetic products;
- d) cooperate to explore validated alternatives to animal testing for cosmetic products to strengthen international regulatory alignment and trade in the cosmetic sector; and
- e) cooperate to reduce the likelihood of animal testing for New Zealand manufactured cosmetic products in the Chinese market, where there is sufficient available alternative safety information.

This understanding will be reviewed following a two year period from the date of your reply in accordance with Chapter 8 (Technical Barriers to Trade) of the Agreement. The review will assess any amendments required to this understanding as a result of changes to policies, regulations and standards related to trade in cosmetic products by New Zealand or China in that period.
