In connection with the signing on this date of the *Protocol to Upgrade the Free Trade Agreement between the Government of the People's Republic of China and the Government of New Zealand* (the "Protocol"), I have the honour to confirm the following agreement reached by the Governments of the People's Republic of China and New Zealand (the "Parties") during the course of negotiations.

Tariffs on the specified product lines shall be eliminated in accordance with the appendix to this letter entitled "Appendix: China – New Zealand Free Trade Agreement Upgrade: Tariff Phasing of Wood and Paper products" (the "Appendix"). Reductions shall occur upon entry into force of the Protocol and thereafter on 1 January of each year, as provided for in the Appendix. The tariff treatment provided in this letter shall prevail over the tariff treatment for the same product lines provided in accordance with the *Free Trade Agreement between the Government of the People's Republic of China and the Government of New Zealand*, done at Beijing on 7 April 2008 (the "Agreement").

I have the further honour to refer to the commitment contained in paragraph 3 in Annex 1 Part A of the Agreement Tariff Schedule of China with respect to Goods Originating in New Zealand Headnote (the "Headnote").

In accordance with Articles 180(1)(a) and 180(2)(f) of the Agreement, the Parties agree that the FTA Joint Commission shall confirm and note the tariff treatment to be extended to New Zealand in accordance with the Headnote (as applicable).

I have the further honour to propose that this letter and Appendix together with your letter in reply indicating such acceptance shall form an integral part of the Protocol and shall enter into force on the date on which the Protocol enters into force for the Parties.
