MINISTERIAL MEETING: 15 NOVEMBER 2024

COMMUNIQUÉ

- 1. We, the Ministers and Ministerial representatives of the Parties to the *Pacific Agreement on Closer Economic Relations (PACER) Plus*¹ met in Brisbane, Australia on 15 November 2024. Our meeting was chaired by the Hon. Leota Laki Lamositele, Minister of Commerce, Industry and Labour of Samoa.
- 2. PACER Plus entered into force in 2020 during unprecedented global health and economic challenges brought on by the COVID-19 pandemic, enforcing international border closures and the transition to virtual work life. We were therefore delighted to meet and talanoa in person for the first time since the Agreement entered into force in December 2020.
- 3. Ministers and Ministerial representatives recalled the first meeting in February 2020, where the unique and close historical, political, developmental, economic, geographic and cultural links that bind us together was recognised. Ministers and Ministerial representatives further recalled the importance that was ascribed to PACER Plus in strengthening economic partnership, supporting sustainable economic development and serving as an important building block towards regional economic integration. Ministers and Ministerial representatives affirmed the continued importance and relevance of these points in 2024.

4. Ministers and Ministerial representatives acknowledged Parties' commitment to enhancing existing partnerships in trade and investment, tailored to the unique needs and capacities of participating Parties and considering the varying levels of development across the region and realising the full benefits of PACER Plus over time.

STATUS OF IMPLEMENTATION

- 5. Ministers and Ministerial representatives noted the progress of the work of the Joint Committee and its subsidiary bodies in the implementation of PACER Plus. We encouraged Parties to continue their work to ensure the smooth and effective implementation of the Agreement.
- 6. Ministers and Ministerial representatives recognised the need for continual improvement to the implementing arrangements for the Development and Economic Cooperation Programme to ensure recipients' priorities are met. We await the outcomes and recommendations from the Corporate Review into the PACER Plus Implementation Unit.
- 7. Ministers and Ministerial representatives acknowledged the importance of the Development and Economic Cooperation (DEC) Work Programme under the Agreement and were pleased with the high levels of support and engagement by PACER Plus Parties, who individually and collectively, had taken advantage of the Programme in order to improve their trading capacity, promote regional cooperation, and improve the enabling environment. We noted the importance of stakeholders, particularly the private sector, as the main user of PACER Plus.
- 8. Ministers and Ministerial representatives appreciated the work done thus far by the PACER Plus Implementation Unit (PPIU) and encouraged the Unit to accelerate the implementation of the work programme, taking into account unique national circumstances of participating Parties.

GENERAL REVIEW OF PACER PLUS

9. Ministers and Ministerial representatives welcomed the outcome and recommendations of the PACER Plus General Review Report completed in 2024, in accordance with Article 1, Chapter 12 to assess implementation of the Agreement to date. We tasked the Joint Committee to commence implementation of the recommendations in the Report. 10. Ministers and Ministerial representatives expressed our satisfaction with the contributions made by PACER Plus as a long-term trade and development agreement, which had enhanced trade readiness among Parties and supported the enabling environment to grow and take advantage of enhanced trade access.

LABOUR MOBILITY

- 11. Ministers and Ministerial representatives recognised labour mobility as a socioeconomic development priority. The significant achievements and efforts to address challenges were noted. Ministers and Ministerial representatives welcomed the Pacific Labour Mobility Annual Meeting (PLMAM) as the regional forum for labour mobility discussions.
- 12. Ministers and Ministerial representatives commended the Australian Government for hosting the 2024 PLMAM and noted the offer by Solomon Islands to host the 2025 PLMAM.
- 13. Ministers and Ministerial representatives noted the recommendations from the Arrangement on Labour Mobility Review Report and tasked the Labour Mobility Working Group to facilitate implementation in collaboration with the Pacific Islands Forum Secretariat, International Labour Organization for Migration and other relevant stakeholders.

ENHANCING PRIVATE SECTOR ENGAGEMENT

- 14. Ministers and Ministerial representatives strongly emphasised the need for targeted assistance through the DEC Work Programme to strengthen private sector capacity to export and to benefit from market access provided under PACER Plus.
- 15. Ministers and Ministerial representatives tasked the Joint Committee to work with the PACER Plus Implementation Unit to refine its approach to private sector engagement in a transparent, effective, and equitable manner, and ensure its inclusion in the next DEC Work Programme. Ministers and Ministerial representatives encouraged complementarity with the Pacific Regional Private Sector Strategy, under the 2050 Strategy Implementation Plan.

PACIFIC REGIONAL INTEGRATION AND PACER PLUS BEYOND 2025

16. Ministers and Ministerial representatives reaffirmed our aspirations for PACER Plus, to increase trade in goods, services, investment and economic opportunities

- for inclusive economic development by participating Parties private sectors, to enhance trade opportunities in the region.
- 17. Minsters and Ministerial Representatives recognised the value of digital trade in unlocking the full potential of our economies and acting as a catalyst for the economic empowerment of women-owned businesses and Micro, Small and Medium Enterprises in both formal and informal sectors.
- 18. Ministers and Ministerial representatives expressed our in-principle support for the renewal of the Implementing Arrangement for Development and Economic Cooperation under PACER Plus-for a further five years beyond December 2025 accompanied by appropriate reforms, as highlighted in the General Review Report.
- 19. Ministers and Ministerial representatives tasked the Joint Committee to consider separate resourcing for the Labour Mobility Work Programme beyond the current phase of support.

PACER PLUS MEMBERSHIP

- 20. Ministers and Ministerial representatives reaffirmed their view that PACER Plus was a framework that would achieve economic integration and that its utility would only increase inclusive membership across other Pacific economies. Noting the cooperative and inclusive principles of PACER Plus and our commitment to the Blue Pacific Continent we encouraged other Forum Island Countries to accede to PACER Plus.
- 21. Ministers and Ministerial representatives reaffirmed their commitment to advocating and promoting PACER Plus in our region as the mechanism for realising socio-economic development benefits through trade in a manner that recognised our collective strengths and our unique individual contributions to the Blue Pacific Continent.
- 22. Ministers and Ministerial representatives noted the statement from the 2024 PLMAM which called for a more sustainable funding approach to ensure sufficient resourcing of the PPIU to progress the impact of the Arrangement on Labour Mobility.
- 23. Ministers and Ministerial representatives extended our appreciation to the Government of Australia for hosting this meeting and looked forward to

convening in 2025 to continue dialogue on implementation	and future direction
for PACER Plus.
